

The Chairman's Statement

OVERALL INDUSTRY PERFORMANCE

During the period 2010/2011, the retirement benefits sector assets grew by 10.2 percent, from Kshs. 426.9 billion in June 2010 to Kshs. 470.6 billion in June 2011. Assets held by the fund managers grew by 9 percent from Kshs. 300.3 billion to Kshs. 326.9 billion while those held by NSSF grew by 17.7 percent, from Kshs. 96.4 in June 2010 to Kshs. 113.5 billion in June 2011.

The property investments held by retirement benefits schemes but not under the control of the fund managers amounted to Kshs. 30.2 billion. The pension industry assets therefore, inclusive of the property held by retirement benefits schemes but not under the control of fund managers hit Kshs. 470.6 billion in June 2011.

The Government Securities continued to be the favorite investment asset class for the pension fund and it constituted the largest share of industry assets in June 2011 with an investment amounting to Kshs 158.7 billion (33.7%), followed by Quoted Equities with Kshs 123.2 billion (26.2%), Immovable Property Kshs 84.4 billion (17.9%) and Guaranteed Fund Investments at Kshs 40.1 billion (8.5%) respectively.



During the period under review, all asset categories exhibited positive growth except Cash which declined by 30.8 percent. However, compared to the results as at December 2010, all asset categories exhibited positive growth except Quoted Equities, Fixed Income and Cash which declined by 5.5%, 7.6% and 26% respectively over the first six months of 2011.

During the first half of 2011, the industry performance reflected the decline in performance in the Nairobi Stock Exchange, the increasing interest rates which reduced bond valuations and the continued leakage from the system due to early withdrawals by members following the gazzetment of the legal notice number 10 of February 11, 2011 which allowed members of individual retirement benefits schemes with deferred benefits to access 50% of benefits arising from employer contributions before retirement age.

INDIVIDUAL RETIREMENT BENEFITS SCHEMES

During the period under review, the individual retirement benefits schemes witnessed a tremendous growth in both the membership and the fund value. The total membership of Individual Retirement Benefits Schemes grew sharply

June 2011 while the total assets grew by almost 22.4 percent to stand at Kshs. 8.57 billion by June 2011 from

Kshs. 7 billion in June 2010.

The sharp growth in the total membership of individual retirement benefits schemes was mainly driven by the growth in the Blue MSME Jua Kali Scheme commonly referred to as "Mbao Pension Plan". The plan was officially launched on 28th June 2011 and has grown tremendously; by end of June 2011 the plan had 7,898 members with a fund value of Kshs.143,708.

The growth in the individual retirement benefits schemes is expected to continue, mainly driven by the Mbao Pension Plan. However, this expected growth may partly be constrained by early withdrawals as witnessed in the first half of 2011 with benefits payment jumping by 111.0 percent to Kshs 1.3 billion in the year to June 2011 compared to Kshs 644 million in the previous year.

RESEARCH

During the financial year, the Authority carried out five research papers. Three papers were done internally by the Authority's staff in the Research Department, one paper was done in collaboration with a university and one was outsourced.

Need and Viability of a BenefiProtection Fund for Retirement Benefis Schemes in Kenya. The study was motivated by the fact that retirement benefits schemes in Kenya were exposed to a number of risks that could jeopardise the ability to pay adequate retirement benefits to members. The paper examined the need and the viability of putting in place a benefit protection fund for retirement benefits. The study found out that even though most of the risks faced by retirement benefits schemes had been mitigated through: the regulatory framework; Risk Based Supervision; changes in scheme design; and existing protection funds, the schemes were still exposed to elements of counterparty default and fraud risks. The paper therefore recommended for the setting up of a retirement benefits protection fund in Kenya that would cover counterparty default and fraud risks.

Analysis of the effectiveness of Annual General Meetings for Retirement Benefis Schemes. The study was motivated by the fact that although the annual general meeting for schemes was mandatory as required by the Retirement Benefits Act; the number of members in attendance had been reducing. One of the factors cited contributing to the low turnout is monotonous nature of AGMs. The need for alternative means of communication to members other than AGMs was therefore desirable. The study findings showed that majority of the trustees understood their roles as trustees; however, there was a need for professional (trained) trustees. The study also established that the annual general meetings were necessary and vital for schemes governance and accountability. The study noted that trustees need to be sensitised and educated on their responsibilities in convening and conducting AGMs.

Impact of assessing retirement benefis before retirement age. The study investigated the impact of accessing retirement benefits before retirement age. In particular the paper looked at the impact to members, scheme and the economy. The paper established that early access of retire-

ment benefits impacted on the adequacy of retirement

benefits to the pensioner. The study also established that over Sh2 billion had been accessed by members in a span of six months. The study therefore recommended for the need to educate members on investment and implications of early withdrawal. The paper also called for the reversal of the amendment in the preservation rule.

Financial and Pension Literacy: A Survey of Pension Scheme Members in Kenya. The paper was done in collaboration with the United States International University (USIU). The objective of the study was to assess the level of finance and pension literacy and determine the financial literacy needs. The paper also examined the challenges to participation in finance and pension education in Kenya. The study used a sample of 2,395 employees drawn from members of 1,308 pension schemes across Kenya based on the RBA register. The results of the study indicated that pension scheme members had higher level of knowledge on pension scheme practices than the general financial literacy issues. The paper identified lack of forum for involvement and lack of understanding of pension schemes matters as major hindrances to participation in pension affairs. The paper therefore recommended for the development and implementation of appropriate pension literacy programs; specifically on pension law, investments, design and computation of retirement benefits.

The Private Sector Analysis Report. The paper was prepared by Consumer Options. The key objective of the paper was to establish the underlying factors which influenced the participation of the self employed in saving for retirement. The results of the study indicated that the self employed and those in the private practice considered working for the rest of their lives and a majority viewed saving for retirement as a product of the low income earners. The paper also noted that poor governance in the pension's schemes was a major hindrance to participation in saving for retirement. The study also noted that there were low levels of awareness on the mandate and functions of Retirement Benefits Authority (RBA) among the self employed and those in private practice. The paper therefore recommended for aggressive marketing of the pension products and public education campaigns.

Retirement Benefis Authority in conjunction with industry stakeholders initiated several of policy measures towards the develop ment of retirement benefis industry during 2010/2011 Financial Year. During 2010/2011 Budget Speech, Finance Minister made a number of policy changes affecting retirement benefis industry.

POLICY RECOMMENDATIONS TO BE PURSUED

Some of the policy recommendations that the Authority will be pursuing from the research findings include:

- 1. The establishment of a retirement benefits protection fund in Kenya that would cover counterparty default and fraud risks.
- 2. Reversal of the amendment of the preservation rule. The Authority will also implement some of the recommendations administratively. These include:
- Comprehensive Trustee Training Programme
- · Aggressive Public Education and Awareness Cam-
- Pension products innovation.

STATISTICAL DIGEST

During the period under review, the Authority published the first statistical digest (Statistical Digest 2009) as part

of the efforts to promote and develop the retirement benefits sector. The digest provides a compendium of data compiled from the annual audited accounts of the Retirement Benefits Schemes in the country. It is our belief that the information in the statistical digest would be of great benefit to researchers, policy makers, academia, students, and most importantly to the players in the retirement benefits industry.

The Chief Executive Officer's Statement



In 2010/2011, the Authority was able to achieve and surpass the majority of its targets. I am pleased to present highlights of our achievements over this period. During the Financial Year we continued to streamline Risk-Based Supervision we launched during the last Financial Year but this year we helped the industry launch Mbao Pension Plan on June 28, 2011.

Risk-Based Supervision

The Authority launched Risk Based Supervision model in Nairobi on June 17, 2010. Risk-Based Supervision (RBS) is a supervisory approach which focuses on the identification of potential risks and the assessment of the financial and operational factors that exist to minimise and mitigate those risks. RBS aims at promoting transparency, provide early warning signals and encourage self-evaluation of risk at regular intervals.

Risk Based Supervision model demonstrates the benefits of moving away from an approach based on strict compliance, specific rules, and quantitative controls towards an approach that puts more emphasis on the identification and management of relevant risks. A risk-based approach encourages supervised entities to place a greater focus on risk management in their daily operations, which outcomes for the members of schemes.

For a long time, regulators within the financial sector have used a rule based system and more or less relied

on financial analysis using ratios as a tool of supervision. Subsequently, it has been realised that relying on financial ratios alone may not be an effective tool for preventing financial crisis in the pension schemes. This has led to the emergence of the risk based approach to supervision which is aimed at promoting transparency, providing early warning signals and encouraging the regulated entities to self-evaluate their position at regular intervals.

As the supervisory model originates primarily in the supervision of banks, it has in recent years increasingly extended to other types of financial intermediaries including pension funds, reflecting an increasing focus on risk management. Its application to pension funds has focused on developments particularly for defined contribution funds that transfer investment risk to fund members. The main objectives for the risk based pension supervision model are:

- Better understanding of Retirement Benefits Schemes' financial position and the possible development in the short and medium term by both the regulator and the regulated entity
- Vary the scope and intensity of supervision in relation to the level of the risk schemes are exposed to

RBA has now formally adopted the Risk Based Supervision as its model of supervision for the retirement benefits industry. Previously RBA placed more attention on compliance status of retirement benefits schemes with little regard to potential risks. Risk based supervision marks a shift to a more pro-active approach as opposed to the previous reactive approach. Why the Authority adopted Risk Based Supervision:

- To gain a better understanding of the quality of management, the characteristics and risks in a scheme and apply consistency in supervision and in assessing compliance
- Schemes will benefit from the improved focus of supervision and understand why particular supervisory tools are used

Mbao Pension Plan

Self employed and informal sector workers can now save for retirement in a convenient way following the launch promotes a stronger pension system and more effective of Mbao Jua Kali Pension Plan that requires minimum daily contribution of Sh20. The pension plan spearheaded by Retirement Benefits Authority gives informal sectors workers opportunity to save for a comfortable retirement

in an easy and convenient way. The pension plan uses the name "mbao" to refer to the minimum contribution of Sh20 a day.

On joining the pension plan by filling in an application form, the pension plan members make payments through M-Pesa or Airtel Money. The pension plan ensures that the scheme members' savings would grow as they will be invested carefully to ensure they earn the best possible return while still remaining secure.

When a member decides to retire, they get back the accumulated contribution plus interest in the scheme and they may choose to use the cash lump sums to purchase an annuity. With Jua Kali sector accounting for 85 per cent of the new jobs in Kenya we are therefore looking forward to Mbao Pension Plan significantly becoming an important player in the country's pension industry. Besides, giving peace of mind to savers during their retirement it is a boon to the country because these savings could be used to finance infrastructure projects, deepen the capital markets and government securities.

Mbao Pension Plan won accolades from Finance Minister Uhuru Kenyatta, who said the pension plan is unique because in addition to expanding coverage to a segment of the population that was not adequately covered, it offers an affordable contribution arrangement. The Minister said that until recently, it was not possible to structure a pension scheme with such low monthly contribution because of high transaction costs of administering it.

Policy changes

The Authority has over the period in conjunction with our parent Ministry - Ministry of Finance - brought changes that have led to this critical industry growing tremendously to 451 billion shillings in assets at the end of December 2010 from 50 billion shillings in 2000. Building on this success, the Government continues to introduce further reforms aimed at securing and consolidating these gains. More recently, Honourable Deputy Prime Minister and Minister for Finance, Uhuru Kenyatta, during the Budget Statement for 2011/2012 as the government sought to lighten requirements of schemes and recognise prisoners for benefits.

First, the Minister exempted schemes investing fully in Guaranteed Funds from having Fund Manager. The implication is that schemes that invest all their assets in Guaranteed Funds of approved issuers, that is, insurance companies will not need to appoint a fund manager, thus

considerably reducing their operating costs, which means higher returns to members. However, the approved issuer will be required to submit half yearly investment reports to the Authority.

Secondly, the Minister removed restriction in National Social Security Fund Act disqualifying a person from receiving any payment in respect of benefit while undergoing imprisonment or detention in legal custody. The result of this is a person undergoing imprisonment may appoint a representative for the purposes of receiving payment of benefits during the term of imprisonment.

Finally, the Minister gave old age safety net to the elderly persons by allocating one billion shillings for cash transfers to elderly persons. Monthly transfer to elderly persons will be raised to 2,000 shillings and coverage will be expanded, which to us as the regulator is welcome since the initiative goes a long way in reducing old age poverty.

Human Capital Development and Administration

The Authority continues talent mapping to ensure the effective utilisation of the resources as we carry out our mandate that includes recruitment, development, motivation and retention of quality manpower. As at the close of 2010/2011 Financial Year, the Authority had a total of 48 employees. On gender distribution, 30 employees, or 2/3 of the employees were male while the remaining 18, or a third were female. This means that no gender accounts for more than two-thirds of the members of staff.

We strive to enhance a superior service-oriented culture while providing benefits to employees that promote health, wellness and a sound work/life balance.

Public Education

RBA continues to undertake public education campaigns to educate Kenyans on the role of the Authority and sensitise them on the importance of saving for retirement.

education campaigns to encourage the Kenyan public to save for retirement. To be consistent with the Authority's mission, "To develop and safeguard the Kenyan benefits sector through commitment to continued excellence in service delivery," RBA came up with a number of pension education programmes targeting different segments of the public. These include:

Trustee Training Seminars

Trustee training is designed to equip trustees with skills to carry out their duties effectively, thus increasing compliance and governance in the industry. Trustee training is tailored to ensure that retirement scheme trustees understand the importance of the role they have accepted. Trustees gain essential knowledge and skills pertaining to their legal and fiduciary responsibilities, scheme governance and retirement scheme investing.

Initially, we assessed trustee training results by examining the number of schemes that had their trustees trained. However, the performance indicator for 2010/11 was enhanced to look at the "total number of trustees trained" opposed to the previous performance indicator which measured "number of registered schemes trained". During 2010/2011 Financial Year, RBA trained 863 trustees, drawn from 244 retirement benefits schemes. In an effort to improve compliance and governance within the sector, the Authority explored the possibility of developing a trustee certification programme. The Authority is collaborating with The Humber Institute of Canada, Association of Retirement Benefit Schemes (ARBS) and the College of Insurance to roll out an examinable trustee certification programme in 2011/2012 Financial Year.

Retirement Planning Seminars

The Authority has always endeavoured to be responsive to the needs of scheme members. As a result, RBA changed the name of the training from "Pre-Retirement Seminar" to "Retirement Planning Seminar," to strengthen the need to start saving early for retirement. The age limit of attendees was also removed to cater for members as young as 30 years. This was in response to feedback that members felt they needed to be enlightened on retirement planning early rather than late in life because the programme was targeting employees who were 50 years and above. Removing the age limit also eliminated the stigma that was always associated with retirement and positioned pension saving

In this regard, the Authority continues to execute public as trendy as any other investment option. As a result, more young people have been attending the seminars and appreciate the Authority's effort in helping them plan for retirement. The Authority is now considering training couples instead of individuals so as to effectively change attitudes on retirement planning.

> During the current 2010/2011 Financial Year, the Authority trained 1,425 retirement benefits schemes members in different parts of the country, which included Nairobi, Eldoret, Mumias and Taveta. Topics covered during the trainings include, attitudes to retirement, time management, personal financial management and psychological issues in retirement.

Retirement Benefits Open Day

This is an annual event the Authority has consistently hosted since 2003 and each year we have a dedicated topic thus underscoring our commitment to ensuring that all Kenyans are well informed on the need to save for retirement. The 2010/11 Financial Year's Open Day theme was: "Saving for a Secure, Sustainable and Adequate Pension," which captured the initiatives we have put in place to raise pension awareness and the importance of saving for retirement among Kenyans. As with previous Open Days, the objective will be to have industry stakeholders and service providers exhibit their services with a view to providing relevant information to workers, scheme members, trustees and general public on issues pertaining to retirement benefits. Also to deepen knowledge about retirement benefits industry, six presentations covering investment, risk management, tax incentives and retirement benefits options available, all aimed at increasing understanding of pensions industry, were made during the two exhibitions.

Operation Ear Drop Kenya Hearing Conservation **Programme**

Retirement Benefits Authority continues to work in partnership with Operation Ear Drop Kenya to facilitate the hearing conservation campaign amongst Kenya's growing informal sector. With the Authority's support, Operation Ear Drop carries out screening for noise induced hearing loss and provides health education and protective ear muffs to the Jua Kali artisans. During this annual event, Jua Kali workers undergo the process of registration, ear examination, hearing assessment, and treatment, which includes issuing them with sets of earplugs.

A noise survey of the Jua Kali sheds was con-

ducted in 2009 at Kibuye in Kisumu to identify sheds that had the highest noise levels, measured in decibels. Of the workers examined, 22 per cent were found to have disabling hearing impairment. The percentage was similar to that which was obtained in the pilot project in Kamukunji Jua Kali sheds in Nairobi which showed that 20 per cent of the workers were affected. This percentage is way above what is found in the general population. The results of the noise survey further indicate that 75 per cent of the workers are exposed to hazardous occupational noise levels exceeding 85 dB(A), on a daily basis. None of the workers had any prior use of hearing protection devices, which are the basic equipment used in prevention of noise induced hearing loss. The majority of them had no knowledge of what preventive measures to take against exposure to excessive noise levels.

It is against this background that Retirement Benefits Authority decided that besides giving Jua Kali workers treatment and earplugs, there was need to find ways of making these workers improve their quality of life now and after their working life. This led to the birth of Mbao Pension Plan, which targets informal sector workers by enabling them to save for retirement by contributing at least Sh20 daily through either M-Pesa or Airtel Money.

During these annual Operation Ear Drop events in Nairobi and Kisumu, it is now a common practice to give the Jua

Kali workers the opportunity to be educated on retirement benefit schemes and how they can benefit from them.

The RBA/OED Jua Kali Hearing Conservation programme is of its kind that targets those workers in the informal sector. The Authority plans to expand the programme to encompass other regions in the country.

Agricultural Society of Kenya Shows

RBA participated in four shows organised by Agricultural Society of Kenya. The Authority took part in Kisumu Regional Show in July, Mombasa International Show in August, Nairobi International Trade Fair in October and Eldoret National Show in March. The shows provide an avenue for the public to learn about the Authority, retirement benefits saving options and their benefits. Also, the shows offer a chance to the public to register complaints with the Authority either regarding a scheme, a sponsor or trustees.





REPORT OF THE AUDITOR-GENERAL ON RETIREMENT BENEFITS AUTHORITY FOR THE YEAR ENDED 30 JUNE 2011

REPORT ON THE FINANCIAL STATEMENTS

I have audited the accompanying financial statements of Retirement Benefits Authority set out on pages 21 to 32 which comprise the statement of financial position as at 30 June 2011, and the statement of comprehensive income, statement of changes in equity and statement of cash flows for the year then ended, and a summary of significant accounting policies and other explanatory information in accordance with the provisions of Article 229 of the constitution of Kenya and Section 14 of the Public Audit Act, 2003. I have obtained all the information and explanations which, to the best of my knowledge and belief, were necessary for the purpose of audit.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the International Financial Reporting Standards and for such internal controls as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for the submission of financial statements to the Auditor-General in accordance with the provisions of Section 13 of the Public Audit Act, 2003.

NOTES TO THE FINANCIAL STATEMENTS FOR YEAR ENDED JUNE 30, 2011

NOTE 1. **Summary of Significant Accounting Policies**

The principal accounting policies adopted in the preparation of these financial statements are set out below:

a) Basis of accounting

The financial statements are prepared in accordance with and comply with International Financial Reporting Standards and the applicable law in Kenya (Kenya Government accounting procedures). The financial statements are prepared in Kenya shillings (Kshs) under the historical cost convention as modified by revaluation of non current assets. The accounting policies have been consistently applied in the current and prior year.

b) Government grants

Government grants and other general grants are accounted for when received. Those of revenue nature are credited to income while those of capital nature are credited to capital fund. Government grants which are used to acquire non current assets are accounted for as per Kenya Government accounting procedures but not in accordance to the requirements of IAS 20.

Fees, interest and other income

Licensing fees paid by service providers and interest income from investments are accounted for on accrual basis.

d) Retirement benefits levy

The levy payable to the Authority by the schemes on the basis of the net asset value of audited fund, is accounted for on cash basis and payable to the Authority six months after the end of the schemes' financial year.

e) Property and equipment

Property and equipment is stated at historical cost or revalued amounts less accumulated depreciation. The depreciation policy is to provide a full charge for non-current assets in use and no charge for those disposed during the year. This is calculated on Reducing Balance Method to write off the cost or revalued amount of non current assets over their useful lives as follows:

Furniture and fittings	12.5%
Equipment	25%
Motor Vehicles	25 %

f) Capital fund

This represents the amount granted by the Government in the prior years to acquire non-current assets at the inception of the Authority and revaluation surplus on non current assets.

g) Over-provision

The over-provision accrued in the prior years is credited to income while under provisions are charged to income of subsequent year.

Retirement benefits obligation

The Authority operated a defined benefits scheme for its staff up to 31.3.2010 and then converted it to a defined contribution scheme and the Authority thus had no obligation to scheme as at 30.6.2011. The assets of the scheme are managed and held by registered fund manager and custodian as per the requirement of Retirement Benefits Act, 1997.

Translation of foreign currencies

Assets and liabilities which are expressed in foreign currencies are translated into Kenya shillings at the rates ruling at the balance sheet date while transactions during the year are translated at rates ruling at the dates of the transactions. The resulting differences from conversion and translation into Kenya shillings are dealt with through income and expenditure statement in the year in which they arise.

Cash and cash equivalent

For the purposes of the cash flow statement, cash and cash equivalent comprise cash in hand, deposits held on call with banks and Treasury bills.

k) Currency

The financial statements are expressed in Kenya shillings (Kshs.)

Staff Loans, Rent Guarantee and Current Account Deposits

These are Interest Earning Deposits placed with the Authority's bankers on both current and special deposit accounts to cater for operational needs and also to facilitate staff loans which are externally administered by the Authority's bankers.

m) Trust Fund and Staff Benevolent Fund.

These are funds held temporarily by the Authority on behalf of its staff and retirees who cannot be traced by their respective retirement benefits schemes. The funds are forming part of liabilities until the establishment of segregated accounts.


