Chairman's Statement



OVERALL INDUSTRY PERFORMANCE

During the period 2011/2012, the retirement benefits sector assets grew by 12.4 per cent, from Kshs. 471 billion in June 2011 to Kshs. 522.6 billion in June 2012. The amount was composed of Kshs. 381.6 billion that was held by the 16 registered fund managers, Kshs.110.9 billion held by National Social Security Fund (NSSF) and an additional Kshs.30.0 billion of property investments held by schemes but not under control of fund managers.

Schemes continued to invest heavily in traditional investments with government securities and quoted equities constituting the largest share of the industry assets, with Kshs.184.1 billion (35 per cent) and Kshs.128.3 billion (24 per cent) invested in each of the asset classes respectively. Another asset class with a considerable percentage investment was immovable property which accounted for Kshs.94.8 billion (18 per cent) of the total assets under management.

The Guaranteed Fund category was the only asset category to experience a decline, falling to Kshs.45.9 billion in June 2012 compared to Kshs.48.0 billion recorded in December 2011.

Chairman's Statement (cont'd)

RESEARCH

During the financial year, the Authority conducted research in four areas. The papers were done internally by the Authority's staff in the Research Department.

Impact of Market Volatility on Kenyan Pension Scheme Long Term Asset Allocation and Risk Tolerance.

The Kenyan financial markets have been greatly affected by market volatility in recent years. The post election violence of 2007, the global financial crisis of 2008/2009 and the steep depreciation of the Kenya shilling in 2011 have all affected financial asset prices significantly. Pension schemes as significant investors in financial assets have been significantly affected by this volatility.

The paper explores how the market volatility may have affected pension scheme investment behavior in terms of asset allocations and risk tolerance.

There is no doubt that there has been significant market volatility as evident from the NSE index, Treasury bill rate movement and offshore indices. This has resulted mainly from aftershocks of the global financial crisis and deepening political uncertainty as the country transitions from a coalition government to a devolved government. The market volatility has impacted on pension scheme performance very strongly, with good periods showing significant positive growth and bad periods of negative performance.

These swings are exacerbated by a significant negative correlation between the NSE prices and interest rates on government securities which together constitute 70% of pension scheme assets.

Policy Recommendations

(i) RBA should ensure all schemes (particularly those with segregated investments) have up to date investment policies and that the strategic asset allocation is included within the investment policy.

(ii) DC (defined contribution) schemes should be encouraged to offer investment choice to their members as currently the impact of market volatility is felt in their account balances yet they have no say in the asset allocation.

(iii) The range of investment opportunities available to Kenyan pension schemes is very limited resulting in overconcentration of portfolios in two assets, namely equities and government securities. This has exposed schemes to great fluctuations in performance in line with market volatility. New uncorrelated investment products like real estate investment trusts, private equity and venture capital need to be introduced in the local market to increase diversification.

(iv) Increased allocation to offshore assets should be allowed at each pension scheme's discretion to reduce the correlated risk of investing wholly in government securities and equities.

Factors Affecting The Uptake of Pension Secured Mortgages in Kenya

This research looked at the mortgage regulations and propose areas for improvement. In addition, the study will look at various ways that can be used to improve the current regulations. In particular, the study will examine the various products used in various countries across the world and recommend best practices.

Based on a ranking of mortgage market constraints, banks identified access to long-term funds as the most important impediment to the growth of their mortgage portfolio. Overlapping constraints of low level of incomes/informality and credit risk were listed as second and third respectively with high interest rates also being regarded as a major constraint. It is worth noting that similar constraints were listed by members of pension schemes with regards to the uptake of pension secured mortgages.

According to the survey analysis on mortgage finance in Kenya, the average mortgage loan is approximately Kshs. 4 million (Central Bank and World Bank, 2010). The survey analysis also showed that the weighted average mortgage interest rate reported by the institutions was 14.07% in 2010.

Recommendations

(i) There is a need to Issue practice notes on the mortgage regulations by Retirement Benefits Authority. The practice notes will outline the regulatory expectation and will demystify the retirement benefits mortgage regulations.

(ii) Training of trustees, members and service providers on pension secured mortgages. It will be helpful to include the mortgage financing companies as co-trainers in the education campaigns.

(iii) The regulations need to be amended to allow members to assign up to 60% as a security for the purposes of purchasing undeveloped land in either rural or urban areas. This has not been explicitly catered for in the current regulations.

Viability of Compulsory Retirement Savings in Kenya The research objectives of the study were:

• By use of case studies, identify the merits and demerits of having a compulsory retirement saving scheme

• To investigate the practicability of a compulsory saving scheme in Kenya

• To make recommendations that may be used for policy change

Policy Recommendations

(i) Compulsory savings for all in Employment Though compulsory the accounts should be treated as individual accounts, where the individual makes the decision on where he would want to save in. To include individuals in the informal sector, there was a need to introduce flexible schemes that would allow members to make periodic payments other than the continued monthly payments in formal employment.



(ii) Contribution rates to be as a percentage of one's salary with a prescribed minimum percent

To be able to give individuals a good replacement rate at retirement, the contribution rates should be as a percentage of one's salary rather than a blanket figure.

(iii) The scheme should be decentralised but highly regulated. The scheme should be a personal defined contribution fund invested by competing asset management firms. The individual is given the option of choosing the particular fund in which to invest in and that there should be flexibility in terms of transfer where workers are allowed to transfer their benefits if they are dissatisfied with the manager's performance. However, the scheme should be regulated as other occupational retirement schemes in the industry.

Do Retirement Benefit Assets Contribute to Economic Growth in Kenya?

This paper therefore sought to answer the following questions: Do retirement benefits assets stimulate economic growth in Kenya? If so, how? And what is its impact?

Policy Recommendations

(i) Review of investment Guidelines: a large proportion of the retirement benefits assets are currently invested in government securities, which basically forms part of the domestic debt of which in most cases are used for budgetary support. This may not translate to the anticipated effects on economic growth. Retirements benefits assets therefore need to be invested in more productive sectors. This study therefore recommends for Economically Targeted Investments (ETI) of retirement benefits assets.

There is therefore need to review the Investment Guidelines so as to enable retirement benefits assets be invested in innovative/alternative market products geared towards the achievement of the desired economic growth and the Kenya vision 2030 objective.

(ii) Sound Macroeconomic Environment: there is need for the government to put in place the necessary fiscal and monetary policy measures aimed at reducing inflationary pressures and ensuring stable and predictable macroeconomic environment which reward savers and reduce fears of inflation.

(iii) Development and Promotion of Innovative Retirement Benefits Products: The asset base to GDP is low compared to the target of 30 percent as envisioned in the Vision 2030 Medium Term Plan. There is therefore the need to develop and promote innovative products in the pension industry particularly those which that the informal sector.

Statistical Digest

The Authority continues to publish the Statistical Digest as part of the efforts to promote and develop the retirement benefits sector. The digest provides a compendium of data compiled from the annual audited accounts of the Retirement Benefits Schemes in the country. The information in the statistical digest is useful to researchers, policy makers, academia, students, and most importantly to the players in the retirement ben¬efits industry.

The achievement of these milestones would not have been possible without the commitment of the Authority's management and staff to the success of RBA through the achievement of its objectives. Chief Executive Officer's Statement



Risk Based Supervision model demonstrates the benefits of moving away from an approach based on strict compliance, specific rules, and quantitative controls towards an approach that puts more emphasis on the identification and management of relevant risks. In 2011/2012, the Authority was able to achieve and surpass the majority of its targets. I am pleased to present highlights of our achievements over this period. During the Financial Year we continued to perfect our Risk-Based Supervision we launched two years ago. Also Mbao Pension Plan, which targets informal sector workers continued to register more member and consequently its fund value went significantly went up. This a big step in the right direction because it shows Kenyans in the informal sector are increasingly appreciating the need to save for their retirement. To assist trustees to develop the skill-set necessary to perform their duties and functions effectively, the Authority early in the year developed Trustee Development Programme Kenya to ensure that member's funds are prudently invested.

SUPERVISION

Supervision continued to form a big part of the Authority's activities in 2011/2012. By June 2012, the total number of registered schemes stood at 1,228.

Risk Based Supervision

The Authority launched Risk Based Supervision model in Nairobi on June 17, 2010. Risk-Based Supervision (RBS) is a supervisory approach which focuses on the identification of potential risks and the assessment of the financial and operational factors that exist to minimise and mitigate those risks. RBS aims at promoting transparency provide early warning signals and encourage self-evaluation of risk at regular intervals. Risk Based Supervision model demonstrates the benefits of

moving away from an approach based on strict compliance, specific rules, and quantitative controls towards an approach that puts more emphasis on the identification and management of relevant risks. A risk-based approach encourages supervised entities to place a greater focus on risk management in their daily operations, which promotes a stronger pension system and more effective outcomes for the members of schemes.

For a long time, regulators within the financial sector have used a rule based system and more or less relied on financial analysis using ratios as a tool of supervision. Subsequently, it has been realised that relying on financial ratios alone may not be an effective tool for preventing financial crisis in the pension schemes. This has led to the emergence of the risk based approach to supervision which is aimed at promoting transparency, providing early warning signals and encouraging the regulated entities to self-evaluate their position at regular intervals.

During the year under review the Authority classified schemes into various supervisory stances as informed by the Risk Based Model. Out of this exercise, those schemes found with high risk exposure were subjected to intense supervision including on-site visits. As RBA continues to implement its Risk Based Supervision model, these forums will continue to provide important opportunities to identify scheme-specific risks, and enhance the efficiency with which these risks are addressed. The full implementation of the system still awaits the Author-

ity's Risk Based Supervision System IT platform, which is under development. Once the IT project, is complete the Authority will link-up with service providers to obtain returns online.

Human Capital Development and Administration

The Authority continues talent mapping to ensure the effective utilisation of the resources as we carry out our mandate that includes recruitment, development, motivation and retention of quality manpower. As at the close of 2011/2012 Financial Year, the Authority had a total of 54 employees. On gender distribution, 33 employees, or 61 per cent of the employees were male while the remaining 21, or 39 per cent were female. This means that no gender accounts for more than twothirds of the members of staff.

We strive to enhance a superior service–oriented culture while providing benefits to employees that promote health, wellness and a sound work/life balance. Through employee orientation and professional development, we foster the values of inclusiveness, comradeship, long–term employee engagement, and life-long learning.

Culture Building We continue with our efforts to nurture a corporate culture that forsters trust, embrace change and values teamwork. Team building exercises are organized regularly for all members of staff to foster mutual understanding, improve communication, and enhance co-operation and coping capacity of team members. Other activities such as Sports Day and Family Day also helped foster cohesiveness.

Training and Development

We attach great importance to staff training and development. An annual training programme plan was formulated, setting out the relevant programmes to be organized according to the needs of staff. We also nominated staff o attend or speak at seminars and conferences to facilitates both local and international exchange and widen their professional exposure and network.

Public Education

RBA continues to undertake public education campaigns to educate Kenyans on the role of the Authority and sensitise them on the importance of saving for retirement. The Authority continues to conduct public education campaigns to encourage the Kenyan public to save for retirement. RBA came up with a number of pension education programmes targeting different segments of the public. These are:

Trustee Development Programme Kenva

Owing to increasing complexity of a trustee's duty, we officially launched Trustee Development Programme Kenya on August 29, 2011. This course leads to certification of retirement benefits trustees so that they get a clear understanding of their roles and responsibilities.

The training is currently carried out by College of Insurance although the curriculum for this five-day course was developed with help from Canada's Humber Institute of Employee Benefits that has been training and certifying Trustees for over 30 years. The training sessions are designed to enhance trustee and retirement scheme officer understanding of investments and the respective investment vehicles available to retirement schemes, the legislative and regulatory environment, trusteeship and the fiduciary responsibilities of trustees, the service providers and their respective roles. Trustees have to attain a pass mark of 70 per cent and above to get certified.

We issued a Practice Note in August 2011 requiring each scheme to have at least one trustee trained under the programme by December 31, 2012. This requirement also applies to Trust Corporations.

Working in noisy environment puts jua kali artisans at hearing loss risk thus the regulator stepped up hearing preservation education in the informal sector. During this 2011/2012 Financial Year, 254 trustees attended and passed the course. The programme has been running for 10 months and 17 classes have been successfully completed with 136 pension schemes being represented. Before the launch of Trustee Development Programme Kenya RBA conducted trustee trainings but due to the need for a more robust training and a structured curriculum RBA internal trustee training has been stopped to give way for TDPK.

Retirement Planning Seminars

The Authority endeavours to be responsive to the needs of scheme members. Through the seminars we enlightens scheme members on pension saving and investment options. After we removed age limit for those attending the seminars, the stigma that was always associated with retirement was eliminated thus pension saving has become trendy as any other investment. As a result, more young people attend the seminars and appreciate the Authority's effort in helping them plan for their retirement. During the current Financial Year, the Authority trained 1,960 members of schemes on retirement planning.

Retirement Benefits Open Day

This is an annual event we have consistently held since 2003 and each year we have a dedicated topic. The 2011/12 Financial Year's Open Day theme was: "Enhancing the Value of Your Retirement through Education" which captured the initiatives we had put in place to raise pension awareness and the importance of saving for retirement among Kenyans.

As with previous Open Days, the objective was to have industry stakeholders and service providers exhibit their services with a view to providing relevant information to workers, scheme members, trustees and general public on issues pertaining to retirement benefits. The 2011 Open Day was attended by 26 service providers. And we went a step further to invite University of Nairobi and Jomo Kenyatta University of Agriculture and Technology to showcase their research findings as we strengthen relationship with institutions of higher learning in sharing knowledge and furthering research.

Eldoret Road Show 2011

RBA in conjunction with Citizen TV and Chamgei FM radio (Kalenjin language), also owned by Royal Media Services held road in Eldoret town on March 2012 to pass the message of saving for retirement to the residents. The message was on the importance of saving for one's retirement and the various available options.

Corporate Social Responsibility

Our commitment to our communities and social responsibility is at the heart of the culture and values that define us as an organisation. We have in place a process to integrate social, environmental, ethical human rights and consumer concerns into their business operations and core strategy in close collaboration with their stakeholders.

We are in partnership with Operation Ear Drop Kenya to facilitate the hearing conservation campaign amongst Kenya's growing informal sector. With the Authority's support, Operation Ear Drop carries out screening for noise induced hearing loss and provides health education and protective ear muffs to the Jua Kali artisans. On June 11, 2012, we held Jua Kali Hearing Conservation Clinic in Kakamega.

During the one week event, with the help of the strong team of ear, nose and throat specialists from Operation Ear Drop Kenya, we educated the artisans hazards on excessive noise, gave them basic ear hygiene, provided information on how to prevent noise-induced hearing loss and provided ear protection devices. A total of 928 Jua Kali artisans were attended to at the Ear clinic. A total of 177 people had their ears syringed to remove wax or foreign bodies. The workers were all issued with earplugs and received instructions on how to use and care for them. Of the artisans attended to, 11 per cent had disabling hearing loss.

Among the metal artisans, the percentage of those with disabling hearing loss rose to 17 per cent and among wood artisans, 14 per cent. As Financial Sector Regulators, we

Financial sector regulators comprise Capital Markets Authority, Insurance Regulatory Authority, Central Bank of Kenya and Retirement Benefits Authority.

Agricultural Society of Kenya Shows

RBA participated in four shows organised by Agricultural Society of Kenya. The Authority took part in Kisumu Regional Show in July 2011, Mombasa International Show in August 2011, Nairobi International Trade Fair in October 2011 and Eldoret National Show in March 2012. The shows provide an avenue for the public to learn about the Authority, retirement benefits saving options and their benefits. Also, the shows offer a chance to the public to register complaints with the Authority either regarding a scheme, a sponsor or trustees.

Achievements and Awards

Retirement Benefits Authority has won two awards during the financial year, mainly due to innovative Mbao Pension Plan that targets jua kali workers because of its flexibility because one uses M-Pesa or Airtel Money to send their contributions. With current membership of 37,040 members and fund value of Sh32.6 million it is an indication of the informal sector potential.

Performance Contracting

Retirement Benefits Authority emerged top among Financial Sector Regulators in the Performance Contracting Results for 2010/2011 Financial Year released on March 26, 2012. 

Nothing has come to the attention of the Directorsto indicate that the Authority will not remain in a going concern basis for at least the next twelve months from the date of this statement.



REPORT OF THE AUDITOR-GENERAL ON RETIREMENT BENEFITS AUTHORITY FOR THE YEAR ENDED 30 JUNE 2012

REPORT ON THE FINANCIAL STATEMENTS

I have audited the accompanying financial statements of Retirement Benefits Authority set out on pages 20 to 31, which comprise the statement of financial position as at 30 June 2012, and the statement of comprehensive income, statement of changes in equity and statement of cash flows for the year then ended, and a summary of significant accounting policies and other explanatory information in accordance with the provisions of Article 229 of the Constitution of Kenya and Section 14 of the Public Audit Act, 2003. I have obtained all the information and explanations which, to the best of my knowledge and belief, were necessary for the purpose of the audit.

Management's Responsibility for the Financial Statements

NOTES TO THE FINANCIAL STATEMENTS FOR YEAR ENDED 30TH JUNE 2012

NOTE 1:

Summary of Significant Accounting Policies

The principal accounting policies adopted in the preparation of these financial statements are set out below

a) Basis of accounting

The financial statements are prepared in accordance with and comply with International Financial Reporting Standards and the applicable law in kenya (Kenya Government acounting procedures). The financial statements are prepared in kenya shillings (Kshs) under the historical cost convention as modified by revaluation of non current assets. The accounting policies have been consistently applied in the current and prior year.

b) Government grants

Government grants and other general grants are accounted for when received. Those of revenue nature are credited to income while those of capital nature are credited to capital fund. Government grants which are used to acquire non current assets are accounted for as per Kenya Government accounting procedures but not in accordance to the requirements of IAS 20.

c) Fees, interest and other income

Licensing fees paid by service providers and interest income from investments are accounted for on accrual basis.

d) Retirement benefits levy

The levy payable to the Authority by the schemes on the basis of the net asset value of audited fund, is accounted for on cash basis and payable to the Authority six months after the end of the schemes' financial year.

e) Property and equipment

Property and equipment is stated at historical cost or revalued amounts less accumulated depreciation. The depreciation policy is to provide a full charge for non-current assets in use and no charge for those disposed during the year. This is calculated on Reducing Balance Method to write off the cost or revalued amount of non current assets over their useful lives as follows:

Furniture and fittings	12.5%
Equipment	25%
Motor Vehicles	25 %

f) Capital fund

This represents the amount granted by the Government in the prior years to acquire non-current assets at the inception of the Authority and revaluation surplus on non current assets.

g) Overprovision

The Overprovision accrued in the prior years is credited to income while under provisions are charged to income of subsequent year.



h) Retirement benefits obligations

The Authority operated a defined contribution scheme and the Authority thus had no obligation to scheme as at 30.6.2012. The assets of the scheme are managed and held by registered fund manager and custodian as per the requirement of Retirement Benefits Act, 1997.

I) Translation of foreign currencies

Assets and liabilities which are expressed in foreign currencies are translated into Kenya shillings at the rates ruling at the balance sheet date while transactions during the year are translated at rates ruling at the dates of the transactions. The resulting differences from conversion and translation into Kenya shillings are dealt with through income and expenditure statement in the year in which they arise.

j) Cash and cash equivalent

For the purposes of the cash flow statement, cash and cash equivalent comprise cash in hand, deposits held on call with banks and short term investment which are highly and readily convertible to known amount of cash and are subject to insignificant risk of change in value.

k) Currency

The financial statements are expressed in Kenya shillings (Kshs.)

L) Staff Loans, Rent Guarantee and Current Account Deposits

These are Interest Earning Deposits placed with the Authority's bankers on both current and special deposit accounts to cater for operational needs and also to facilitate staff scheme loans which are externally administered by the the Authority's bankers.

M)Trust Fund and staff Benevolent Fund.

These are funds held temporarily by the Authority on behalf of its staff and retirees and/or their beneficiaries who cannot be traced by their respective adminstrators of retirement benefits schemes. The funds are forming part of liabilities until the establishment of segregated accounts.
